Non-Financial Assets Management of the Government – Buildings

In order to ensure the proper management of Non-Financial Assets of the Government, as emphasized by the Cabinet Decision dated 25th October 2022 on “Management of the Non-Financial Assets of the Government” also, updating the information of buildings by the Public Sector Institutions is required and your attention is drawn to the instructions given by the Assets Management Circular No. 01/2017 dated 28th June 2017 with subsequent circulars thereto.

02. Accordingly, all the Heads of Public Sector Institutions are required to submit the updated information of buildings owned (including rented out spaces) and buildings rented/leased by the respective institution as at 31st December 2022 to the Comptroller General’s Office through email (cgo@mo.treasury.gov.lk) on or before 15th March 2023, as per the Annexure herewith.

03. In addition, to ensure the efficient allocation of building spaces, the prior consent of the Comptroller General should be obtained for the allocation of spaces of Government buildings.

04. Your cooperation in this regard is highly appreciated.
